#### **Approval of Previous Meeting:**

3. Mr. Galloway presented the Mental Health Allocation Plan and discussed all of the components of the plan in a PowerPoint presentation. Discussion was had regarding what mental health counselor the school had been using and the effectiveness of providing this service to those students in need.

- 4. Dr. Thorson led the **Construction Update**. Spoke about having to extend the contract on the land, due to the fact that Palm Bay would like a turning lane to put in that would put the project out of reach. Mr. McKinney has decided to put a team together to lobby the council in order to have that requirement dropped, thus putting the plan back on target. No vote was completed on this report.
- 5. Mr. Galloway provided his **Principal Report**, which included the good news that Educational Horizons Charter is "A" rated once again. He spoke about areas that needed to be improved, reading across the board and math facts in all grades. He talked about staffing and areas we are still hiring. We are still looking for two certified reading teachers for our students. We have multiple interviews scheduled and are optimistic. He also introduced Josephine Parker, our new Assistant Principal, ESE teacher, and all of her duties and attributes. No vote was conducted for this report.
